RESERVATIONS: Must be 21 years of age to reserve.

PAYMENTS: We accept all major credit cards (Visa, MasterCard, American Express & Discover). Pricing may vary. There is a **\$175.00** deposit required at time of booking to hold your reservation and it will be applied towards the total cost of your trip. The remaining balance will be charged the day before your party. The driver will not begin your trip without being paid in full. A credit card must be used for deposit. Payment of full lease is to be paid upon arrival unless full payment is received in advance. A **\$35.00** fee will be charged for bad credit card processing.

ARRIVAL: Please, arrive 15 minutes before scheduled to start, so all waivers can be signed by every individual that steps foot on the bus. We cannot hold the bus if you are not on time. If you do not arrive on time you will be considered a "No-Show." Party Bus riders can be delayed up to 30 minutes, after that, you will be considered "No-Shows" and the trip will be cancelled or rebooked with those on standby. Party Bus riders that have a delayed departure will not have time "made up". Your late arrival eats into your existing time slot and will not be recovered at trip end.

PROHIBITED: Under-age Alcohol Consumption and Drug Use is prohibited by law. The driver has the right to terminate run without refund (if there is blatant indiscretion on the part of the guests).

- ABSOLUTELY NO WEAPONS ALLOWED.
- SMOKING / VAPING IS STRICTLY PROHIBITED IN OUR VEHICLES. Failure to comply will result in a \$250 fine and the driver may terminate the trip with no refunds. Feel free to ask the driver to stop for breaks as many times as you need.
- Guests on our bus extending any part of their bodies outside the windows or doors of the bus or throwing any objects from the bus is prohibited.

TRIP TERMINATION: For any actions such as fighting, violence, damage to equipment and/or bus, harassment toward the driver, staff, or anyone else in or around Destin Party Bus, LLC, the driver reserves the right to terminate the trip at any time. The client will be held responsible for finding other transportation and forfeits the full fare as a result.

There is a 4-hour minimum rental for all reservations; overtime in one-hour increments will be applied if you exceed 15 minutes over the pre-arranged time at your agreed hourly rate.

DAMAGES: You are responsible for yourself and other guests regarding damage to the vehicle. This includes but is not limited to gum, smoking, beverage spills, burns, rips and tears of interior, vomiting, urine and breaking of any glassware or equipment. There is a minimum replacement charge of **\$500.00** for any damaged or missing equipment. If anyone gets sick in the vehicle and discharges any bodily fluids, there is a **\$250.00** clean up fee that will be charged to the credit card on file.

LIABILITY: By signing up for and participating in the ride, the individual agrees that Destin Party Bus, LLC and its employees are not responsible for any claims for injuries, loss, damage, death, liability, criminal or civil litigation for the participating individual arising out of or relating to a ride.

- Destin Party Bus is not responsible for lost or stolen items during or after the completion of the rental.
- Destin Party Bus shall not be held responsible for late arrivals caused by acts of nature, traffic delays, breakdowns, incorrect pickup or drop off information and any situation beyond Destin Party Bus control.
- Pictures and/or videos taken by our staff may be used for website/internet purposes; you are giving authorization to Destin Party Bus by executing this contract. If there is an entertainer on your bus, they have the right to disallow photos being taken of them.

CANCELLATION POLICY: The deposit you put down will be forfeited if cancelled within 7 days prior to your event, you will be responsible for the **\$175.00** deposit and a **\$100.00** cancellation fee. If you cancel within **48** hours of the booking, you will be responsible for 100% of the rate charged.
